

**MINUTES OF THE CITY COUNCIL MEETING OF THE  
CITY OF NASHVILLE, ARKANSAS  
SEPTEMBER 22, 2015**

The City Council of the City of Nashville met on Tuesday, September 22, 2015 at 6:00 p.m. in the City Hall Council Chamber for the regular monthly meeting.

Presiding Officer Mayor Billy Ray Jones called the meeting to order.

Jimmy Dale led the Council in prayer.

Chief Pierce led the Pledge of Allegiance.

Roll call, all members were present with the exception of Mike Milum. Others in attendance were City Attorney Brasel, Nashville Leader, Nashville News, SW Arkansas Radio and City Clerk Woodruff.

Monica Clark made a motion to accept the minutes and was seconded by Matt Smith. There were 11 yeas and 0 nays.

Jimmy Dale presented financials and explained the extraordinary expenses. He stated that August was a good month and that the City closed the month with \$85,000.00 income over expenses even after some pretty big ordinary expenses. The Police Department had purchased a new car, the remodeling of the old jail and repairs to the levee/spillway. Vivian Wright made a motion to accept the financials with a second by Joe Hoen. There were 11 yeas and 0 nays.

Public Works Director, Larry Dunaway was out of town looking at a radio read system and a chlorine system. The Mayor told the Council that ADEQ had closed out the waste treatment plant project. The islands in the middle of the sewer pond were sludge islands and had always been there but were showing because we were not pumping in those ponds anymore. He also told the Council that all debris had been burned.

Wendy Harris was next with an update on the park. The Golden Gathering has been scheduled for 10-8-15 with entertainment by the group Shake, Rattle and Roll. The Trick or Treat trail will be held on October 31. Wendy stated that they were advertising for a part-time maintenance position. The bids for the 2014 Grant has gone out to rebid as we only had one bid at the previous bid opening. The bids will be opened at 10:00am on 9/28/2015 at City Hall. Wendy also stated that they were taking sealed bids on the old wooden light poles.

Chief Pierce reported that the remodel at the jail was nearing completion. He stated that one of his officers had been up at the ABC school and had used radar on approximately 80 vehicles and only 2 were stopped for over the speed limit.




