

**MINUTES OF THE CITY COUNCIL MEETING OF THE
CITY OF NASHVILLE, ARKANSAS
MARCH 22, 2016**

The City Council of the City of Nashville met on Tuesday, March 22, 2016 at 6:00 p.m. in the City Hall Council Chamber for the regular monthly meeting.

Presiding Officer Mayor Billy Ray Jones called the meeting to order.

Jimmy Dale led the Council in prayer.

Larry Dunaway led the Pledge of Allegiance.

Roll call, all members were present with the exception of Donna Harwell and Jimmie Lou Kirkpatrick. Others in attendance were Nashville News, SW Arkansas Radio, The Leader, Wendy Harris, Aaron Brasel, Jimmy Dale, Dennis Green, Larry Dunaway, and City Clerk Woodruff.

Monica Clark made a motion to accept the minutes and was seconded by Vivian Wright. There were 10 yeas and 0 nays.

Jimmy Dale presented financials and explained the extraordinary expenses. Franchise Fee Fund has received \$56,000.00 with more due from a park grant. We have been approved for payment from FEMA but still have not received the funds. With there being no questions Joe Hoen made a motion to accept the financials with a second by Carol Mitchell. There were 10 yeas and 0 nays.

Public Works Director, Larry Dunaway told the Council that the bids on the Hwy Dept. sidewalk project should hopefully be done by the end of May. He stated that there was a request on the agenda for 2 resolutions for Natural Resource but that he did not have his paperwork ready so he would address them later. Spring Clean-up will be the week of April 9th through the 17th. By running it those dates Dunaway stated that it would give the citizens two full weekends to place the stuff they wish to dispose of. Dumpsters will be set at the usual places.

Park Director Wendy Harris gave the Council an update on the park and its projects and activities. The soccer program has started as well as T-ball and baseball. She stated they are gearing up for the Spring Fling and the Easter Egg Hunt. Dinofest will be May 27th and 28th.

Chief Pierce was not in attendance but the Mayor stated there was nothing significant to report and said that all seems to be going smooth at the police department.


Next on the agenda was Ordinance 939 in regards to the Transient Peddlers Permits. The purpose of rewording the ordinance is to stop door to door sales. 
Mr. Bob Martin. Aaron Brazell stated that he would look over the ordinance and see what needed to be done to clarify the wording.
